3LYON PRESTIGE CARD TERMS AND CONDITIONS ("TERMS AND CONDITIONS")

1. Introduction

1.1 3Lyon Prestige Berhad (Company No.: 1316250-P) is a public company incorporated in Malaysia with its business address at C3-6-13 Solaris Dutamas, Jalan Dutamas 1, 50480 Kuala Lumpur, Malaysia ("the Company").

1.2 The Company is the promoter of a lifestyle card which is known as '3Lyon Prestige Card' ("Prestige Card").

1.3 The holder of the Prestige Card is entitled to benefits offered by the participating merchants ("Participating Merchants") that are listed on the Company's website located at www.prestige.3lyonholdings.com ("Main Website").

1.4 This Terms and Conditions shall constitute entire agreement between the holder of the Prestige Card ("Member") and the Company subject to any variations made from time to time in accordance to clause 12.2 of this Terms and Conditions. As a holder of the Prestige Card, the Member understands and hereby agrees with the Company to be bound by the provisions as described under this Terms and Conditions and any amendments and variations made herein.

2. Requirements for the Applicant

2.1 For the applicants who are interested to apply for the Prestige Card, such applicants shall satisfy all requirements as described below:-

- (a) the applicant must be an individual; and
- (b) the applicant must be eighteen (18) years and above.

3. Registration Processes

3.1 The interested applicant can apply for the Prestige Card by completing the application form ("Application Form") as provided by the Company and submit the completed Application Form directly to the Company at the address as designated below:-

3.2 The interested applicant will be notified of the status of the application made within seven (7) working days from the date the Company receive the Application Form.

3.3 For approved application

- (a) The Company shall issue confirmation letter to the successful applicant ("Confirmation Letter").
- (b) Upon issuance of the Confirmation Letter by the Company to the applicant and clearance of membership fees, the Company shall register the applicant as a 'Member' and issue Prestige Card (depending on the type opted by the applicant in the Application Form) in favour of the applicant.

3.4 For rejected application

- (a) The Company shall issue rejection letter to the applicant ("Rejection Letter") and make refund for any payment made by such applicant for the membership fees, if any, within fourteen (14) working days from the date of the Rejection Letter. For avoidance of doubt, the interested applicant hereby agrees that the Company shall not be obligated to provide any reasons for such rejection and such decision is at the sole discretion of the Company.

4. Type of Prestige Card

4.1 There are two (2) types of Prestige Card that may be issued by the Company:-

- (a) the Reserve Prestige Card; and
- (b) the Paramount Black Prestige Card.

4.2 Reserve Prestige Card

(a) Membership Period

(i) The membership period for the Reserve Prestige Card shall be for a period of twelve (12) months commencing from the date of Confirmation Letter issued by the Company to the Member ("Reserve Prestige Membership Period").

(b) Membership Fee

(i) The Member is required to pay Ringgit Malaysia One Thousand Nine Hundred Ninety Nine (RM1,999.00) only to the Company being the membership fee for the Reserve Prestige Card for the Reserve Prestige Membership Period ("Reserve Prestige Membership Fee").

(c) Benefit

- (i) The Member is entitled to the benefits offered by the Participating Merchants including discounts, promotions and/or cash back rewards.
- (ii) The Member can only claim for the benefits by displaying the Reserve Prestige Card to the person-in-charge at the Participating Merchant's outlet before or upon the transaction for the purchase of goods and/or services by the Member at such Participating Merchant's outlet or by login into the Member's membership account at the Main Website ("Membership Account") and then proceed to purchase the goods and/or services from the Participating Merchants.

4.3 Paramount Black Prestige Card

(a) Membership Period

(i) The membership period for the Paramount Black Prestige Card shall be for a period of one hundred twenty (120) months commencing from the date of Confirmation Letter issued by the Company to the Member ("Paramount Black Membership Period").

(b) Membership Fee

(i) The Member is required to pay Ringgit Malaysia Nine Thousand Nine Hundred Ninety Nine (RM9,999.00) only to the Company being the membership fee for the Paramount Black Prestige Card ("the Paramount Black Membership Fee").

(ii) The Member is also required to pay additional Ringgit Malaysia One Hundred (RM100.00) only for every twelve (12) months as annual fees throughout the Paramount Black Membership Period.

(c) Benefit

- (i) The Member is entitled to the benefits offered by the Participating Merchants including discounts, promotions and/or cash back rewards and with an annual spending of at least RM1,000.00, the Member is entitled to a minimum cash back reward for every twelve (12) months throughout the Paramount Black Membership Period amounting to RM700.00 for the first 3 years of the Paramount Black Membership Period and RM1,700.00 cash back reward for the subsequent years of the Paramount Black Membership Period with an annual spending of at least RM2,000.00 by the Member.
- (ii) The Member can only claim for the benefits by displaying the Paramount Black Prestige Card to the person-in-charge at the Participating Merchant's outlet upon transaction for the purchase of goods and/or services by the Member at such Participating Merchant's outlet or by login into the Membership Account at the Main Website and then proceed to purchase the goods and/or services from the Participating Merchants.

4.4 Disclaimer of Liabilities

- (i) The Member shall also be subjected to the terms and conditions imposed by the Participating Merchants for any transactions entered between the Member and the Participating Merchants for the goods and/or services purchased by the Member.
- (ii) The Member agrees that all transactions entered by the Member with the Participating Merchant are at the Member's own risk and the Member acknowledges that the Company shall not be liable or take responsibility for the goods and/or services offered by the Participating Merchants including but not limited to the delivery, quality (including any defects or deficiency in the goods and/or services), safety or the fitness for purpose of the goods and/or services purchased by the Member from the Participating Merchants.

5. Personal Data Protection

5.1 As a holder of the Prestige Card, the Member hereby agrees that the Company, including but not limited to its partner, employees, agents and/or representatives, may collect, store, process and/or use the Member's personal data, which may include but not limited to the Member's name, address, telephone number and email address ("Personal Data"), for the purposes such data was collected, which among others are to provide information to the Member.

5.2 The Member hereby gives consent to the Company, including but not limited to its partners, employees, agents and/or representative, to disclose the Personal Data to relevant authorities and/or third parties, where required by law or for legal purposes.
